New Health Regulations Affect Us All

From the Health Officer...

As we begin this new year, the big news in my department are the new and revised food codes published in the Pennsylvania Bulletin. These upgrades and new rules bring the Commonwealth's food safety standards into step with the current national standards for food safety. The rules apply to all public food establishments in Pennsylvania. Any eating and drinking establishment that sells food to the public for one (1)day up to fourteen (14) days is classified as a temporary food facility. Any establishment operating fourteen (14) days or more per year is classified as a permanent food facility.

These facilities are inspected annually and must meet the required standards to receive an operating permit (eating and drinking license). This license is renewed annually. Many of the requirements and standards have been in the previous codes, but are now more extensive.

The following is a summary of the important changes that are required of food handlers and food handling establishments in Pennsylvania.

The food handlers are required to monitor more closely temperatures on hot and cold foods by using accurate thermometers. They must verify sources of foods, especially meats, poultry, and seafood, and the temperature of the product at delivery to the establishment.

Employees and employers are requires to monitor and report any infectious problems or diseases that are transmittable through food. Food handlers may no longer handle any prepared, ready to eat (RTE) food with bare hands. They must use tongs, spatulas, wrappers or gloved hands when handling RTE foods.

Hand washing sinks must be easily accessible in food preparation areas and hands must be washed before putting on single-use gloves. Hair must be restrained or covered and facial hair must be covered.

The above conditions are to be monitored by the Person in Charge (PIC). The PIC may be the owner, manager, supervisor or someone designated as a PIC. A PIC must be present at all times when the establishment is open for

The latest International Property Maintenance Code of 2003 requires smoke detectors to be installed in the following locations in homes: one in each bedroom, one in the immediate vicinity of each bedroom, and one on each story of the home, including the basement.



On December 9, 2003, the Borough Council appointed Darvin Straub to fill the unexpired Council seat made vacant by Paul Bowersox's death.



Chief of Police Lawrence Redington retired on December 31, 2003. Larry had served the Borough in this capacity since March of 1993. A retirement dinner in his honor was held at the Front Street Station with Larry's family, **Borough Council** members, and Borough employees present. Mayor and Mr. Brosius hosted the event. We wish Larry well in his future endeavors.

Snow and Ice Removal Policies

Borough Ordinance #17 states, "It shall be unlawful for the owner or occupant of any property in the Borough of Northumberland to allow snow and ice to remain on the sidewalks abutting or pavements abutting their several premises and property for a longer period than twenty-four (24) hours after snow has fallen or ice has accumulated."

The fine for violating this ordinance is \$100 for each 60 foot section (or less) of sidewalk. Please see that your sidewalks are cleared within the required timeframe.

The Street Department appreciates the residents' con-

sideration during a snowstorm. Residents should park on the designated side of the street (Mondays, Tuesdays, and Wednesdays) in order to assist the crew as they clear the streets. On other days, it is recommended that vehicles are parked on one side of the street so the crew can clear the other side. If residents voluntarily coordinate the parking throughout the neighborhoods on days that are not posted, the crew will be able to better clear streets.

Whenever the Borough experiences excessive snow and ice, the Mayor or President of Council may declare a Snow Emergency. In conjunction with the Snow Emergency, the Mayor or President of Council may, among other things, direct that the parking prohibitions shall be in effect on designated days other than Monday, Tuesday, or Wednesday. When a snow emergency has been declared, it shall be unlawful during the period of the emergency for any person to park a motor vehicle or truck tractor upon any street that is posted as a "Snow Emergency Route". Should a Snow Emergency be declared, information will be provided to the local media.



I would like to take this time to remind all residents of the Borough ordinances as they pertain to snow and ice: 1. It is unlawful to permit snow and/ or ice to remain on sidewalks or pavements beyond 24 hours after the storm has ended. 2. It is illegal to shovel or place,



snow and/or ice upon any street for a distance beyond 4 feet from the curb or the edge of the road. The police department has secured a grant from the Department of Justice. Project Child Safe is a program which provides free gun locks to gun owners. business.

Consumers can help to protect themselves and at the same time ensure safer food handling practices by reporting improper food handling to the PIC. If they do not get a satisfactory reaction, then the matter should be reported to the local health department. Borough residents should contact the Borough Office at 473-3414 with any concerns.

In closing, I wish to compliment the *Daily Item* for the fine front page news article on food safety related to these new food codes. (Tues., Dec. 16, 2003) This column and the Daily Item article are a condensation of 100 pages of revised food regulations.

Some of these changes are going to be difficult for some food handlers. Old habits and routines are hard to change; but change is necessary in order to safeguard and provide safer food for the consumer.

Again, I remind people to be observant and speak up when bad/ poor food handling is observed. With your help we can all feel more secure about the food we get at our restaurants, delis, and taverns.
