HOLIDAY HOUSE TOUR SET

Mark your calendar for the 5th Annual Holiday House Tour, Sunday December 11. The Sunbury Area Chapter of Red Cross, an agency of the United Way, sponsors the tour which will be held from 1:00 to 5:00 p.m. In case of heavy snow, it will be held on Monday, December 12 from 6:00 to 9:00 p.m.

All homes are located in the Northumberland/Point Township area and will be beautifully decorated for the holidays. Tickets will be \$8.00 per person or 2 tickets for

\$15.00. Advanced tickets may be purchased in Sunbury at the Red Cross Office, 30 N. 5th St., Medical Center Pharmacy, and First Susquehanna Bank & Trust. In Northumberland, tickets are available at Gubin's, Northumberland National Bank, and Townside Garden Cafe. Tickets will be on sale Sunday, the day of the tour, from 12:30 to 3:00 in the King Street Park. With each ticket, you will receive a booklet with a map of the houses on the tour. There will also be red cross signs to follow for directions.

Light refreshments will be served throughout the tour.

Money generated from the tour helps provide food, shelter and clothing for local families within the Sunbury Area Chapter.

One of the homes on this year's tour is the home of James and Phyllis Kohl, Ridge Road, a stone farm house built in the late 1700's. The house was completely gutted and rebuilt. The log addition was added in 1988 when the Kohl's purchased a log

New business welcomed to Borough

Clinical Outcomes Group, a private 501 C E non-profit health and social services organization, recently opened an office at 65 King St., Northumberland, PA.

Overview: Currently serving as the administrator of the tobacco settlement funds, as appointed by the Pennsylvania Department of Health in Snyder, Union, Northumberland, Montour, Columbia and Schuylkill counties, Clinical Outcomes group was first established in 1999 in Pottsville, PA by David Zanis, Ph.D. Initially, in Pottsville, Clinical Outcomes Group provided tobacco cessation programs and victim services. These services have been expanded and are now offered in the 6-county region. Additionally, Clinical Outcomes Group acts as grant administrators in Pennsylvania and several neighboring states. Clinical Outcomes Group is concerned with the health of our communities and works to improve it by providing free programs to help people quit using tobacco products, help children to not start using tobacco products and help businesses and other organizations to become tobacco free and provide clean indoor air to their customers and employees through careful planning and policy development.

BOROUGH CODES YOU SHOULD KNOW

Snow Removal

Snow and ice must be removed from sidewalks within 24 hours after snow has fallen or ice has accumulated. It is unlawful to shovel or place snow on any portion of any street in the Borough of Northumberland except that portion of the street extending four (4) feet center ward from the curb or from the edge of the paved portion of the street if there is no curb.

Rubbish & Dumpsters

It is declared as a nuisance to accumulate garbage, junk and rubbish and to store abandoned or junked automobiles in the Borough of Northumberland, except on public dumping grounds; and it is directed that all dangerous structures on public or private grounds shall be prohibited.

All porches, carports, sheds and yards, open and visible to the public eye or adjacent to sidewalks utilized by the public shall remain free of discarded or broken household furnishings, dumpsters, appliances, junk, etc. and similar items, excluding the type designed for use in such structures. Such structures and areas shall

be kept in a sanitary and orderly manner, free of litter, rubbish and garbage not stored in approved covered containers as required by law. All such discarded items and their containers shall be removed from such structures or areas within 24 hours.

Parking Restrictions on Borough Streets

Parking is hereby prohibited during the entire year from January 1 to December 31 between the hours of 8:00 a.m. and 4:00 p.m. at the locations herein set forth. This parking prohibition is unconditional, that is, parking is prohibited during the entire time between 8:00 a.m. and 4:00 p.m. no matter if said streets, alleys or highways are or are not being, or have or have not been, swept or cleared of leaves or snow:

On Mondays:

the odd numbered side (the southwestern side) of King Street, Hanover Street, Wallace Street, and North Avenue

the even numbered side (the northeastern side) of Queen Street, Orange Street, and Prince Street

the odd numbered side (the northwestern side) of Priestley Avenue, Water

Street, Front Street, Second Street, Fourth Street, and Sixth Street

the even numbered side (the southeastern side) of Third Street, Fifth Street, and Seventh Street

the sides of King Street next to the King Street park except metered areas of said streets.

On Tuesdays:

the even numbered side (the northeastern side) of King Street, Hanover Street, Wallace Street, and North Avenue

the odd numbered side (the southwestern side) of Queen Street, Orange Street, and Prince Street

the even numbered side (the southeastern side) of Priestley Avenue, Water Street, Front Street, Second Street, Fourth Street, and Sixth Street

the odd numbered side (the northwestern side) of Third Street, Fifth Street, and Seventh Street

the sides of King Street across from the King Street park.

Also,

Parking is prohibited on Wednesdays between the hours of 8:00 a.m. and

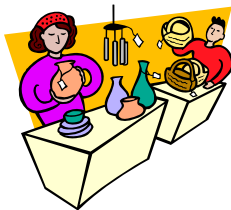

HEALTH OFFICER REPORT

Summer is finished but there is still enough warm weather left for us to avoid mosquito-breeding places. Eliminate any places for stagnant water, mosquitoes can and will breed up to heavy frost. West Nile Viral disease is a very serious problem.

Picnic season is over for the most part, but safe food handling is necessary all year. Protect all foods from bugs and flies. Keep cold foods cold (40° F or below) and hot foods hot (at or above 135° F)

Any food left in the danger zone (41° to 135°F) for more than 2 hours should be discarded. Handling ready to eat food (RTE) with bare hands is a violation of PA Food Code/law. When you see this violation in a public eating place you should refuse to accept the

food and report the episode to the management. If they choose to ignore your observation, report the matter to the Health Department in which the incident occurred.

Hand washing: Commercial hand sanitizers are acceptable but should not be a substitute for hot water and soap hand washing. Wash your hands often, especially before handling any food. A frequent source of food contamination and food born illness is attributed to improper food handling such as unclean hands and or utensils. Keep it clean, stay healthy!

Borough Codes You Should Know

4:00 p.m. in the Sunnyhill, Villa Vista and Hilltop view sections of the Borough.

Parking is prohibited on Wednesday mornings between the hours of 7:00 a.m. and 8:00 a.m. on all streets metered for parking areas in the Borough.

Burning

Dry paper only may be burned between the hours of 7:00 a.m. and 5:00 p.m. on Wednesday, and 7:00 a.m. and 11:00 a.m. Saturdays. The fire must be contained in a block, brick, concrete, or metal receptacle **located not less than 15 feet from any building**, and covered with a screen or cover containing holes not larger than 1 inch square during the time that the fire is burning. A person over the age of 16 must remain within 15 feet of the fire during the entire time that the fire is burning and must extinguish the fire before leaving the area.

Dogs

Owners must control their dogs on public property by restraining them by a leash or other appropriate restraining device. No person shall permit any dog to enter onto any public property which is posted or upon the private property of another without the permission of the owner of the property.

Curbing of dogs is required. If a dog defecates on public property the owner shall, immediately after the dog has deposited his feces, remove

in a sanitary manner all such feces so deposited, and provide that said feces shall be wrapped or enclosed and deposited in said person's garbage or in some other place approved by the Health Officer in such a manner so as not to cause an odor or a hazard to the health of any resident of the Borough.

It shall be unlawful to have any dog which disturbs the peace by barking, howling or making other loud noises to the annoyance and discomfort of any person in the Borough of Northumberland. The barking, howling or making of other loud noises by any dog for one-half (1/2) hour or more shall be deemed to be a disturbance of the peace.

Grass

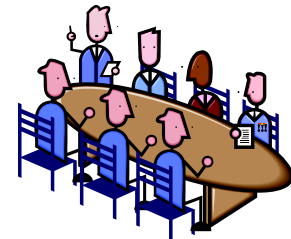
Property owners must cut and mow the grass and weeds on their properties and in the space between the property line and the curb (or if there is no curb, the paved or traveled portion) of any street or alley, so that neither grass nor weeds is above the height of six inches.

It shall be unlawful for any person to knowingly cause grass clippings, leaves, or other debris or waste produced in conjunction with yard maintenance or gardening onto the streets, alleys, and other public roads of the Borough of Northumberland. A homeowner is responsible to ensure that any persons hired to cut their grass or maintain their yard abide by this ordinance. Any grass or waste, which inadvertently is caused to enter the streets or alleys of the Borough, shall be promptly

removed; **there is no "grace period" within which to remove grass or leaves.**

Curfew for minors under the age of 17

Any minor under the age of 17 years may not be unsupervised within the Borough of Northumberland between the hours of 11:00 p.m. and 6:00 a.m. of the following day unless the minor is accompanied by his or her parent, guardian or other adult person having the care and custody of the minor or the minor is on an emergency errand or legitimate business directed by his or her parent, guardian or other adult person having the care and custody of the minor.

CHRISTMAS TREE PICKUP SCHEDULE ANNOUNCED

Northumberland Borough will have Christmas tree pick-up from Jan. 3rd thru Jan. 18th, 2006.

The final dates for pick-up will be January 16, 17, and 18 following the street-sweeping schedule. On these final days, the trees must be placed between the curb and sidewalk by 8:00 a.m. The crew will drive down each street

once and will not go back for trees that are put out after they have completed that street.

Trees will not be picked up if they are covered with bags or have any type of ornaments or trimmings, including tinsel, on them.

The Borough employees appreciate the residents' co-operation.



New business welcomed to Borough

Cessation Services: The smoking cessation program, Quit and Win, was developed by Clinical Outcomes Group and takes an individual, strength based approach to helping people to stop using tobacco. The program begins with one 90-minute fun-filled workshop followed by individual "coaching" and support for the participants. FROM THE CHIEF: TIM FINK

Borough Residents,

School is now in progress and school buses are picking up children throughout this Borough. Most residents know that they have to stop for school buses with activated red signals flashing, but some residents might not know that when a school bus with activated red signals is stopped at an intersection, all vehicles within the intersection must stop until the red signals are turned off, even if they are planning to turn and not pass the school bus. This violation is Vehicle Code 3345, Meeting or Overtaking School Bus, and is a \$250.00 fine plus court costs and other fees.

Recently the Borough erected four (4) new stop signs at the following loca-

tions: one on Jefferson Street at Madison Avenue, one on Prince Street at Seventh Street, and two stop signs on Westway (formerly Penn Street) at Fourth Street.

Another reminder to residents is that the posted speed limit on Strawberry Road is 25 m.p.h. Many motorists drive over the posted speed limit. This department will be checking for speed violators at this location and other areas in the Borough. As an example of a violation of Vehicle Code 3362, Maximum Speed Limits, a motorist cited for traveling at a speed of 40 MPH. in a

25 MPH speed zone will receive a \$55.00 fine, a \$10.00 EMS fee, a \$30.00 Cat fund fee, \$30.50 Court cost fee, and a \$10.00 JCP fee which totals a \$135.50 fine to the motorist as well as three (3) points on their

driving record. Please observe the posted speed limit signs

throughout the Borough and drive safely.

Residents should contact this department with any frequent traffic violation areas of town and we will do our best to enforce them.

What would you like to see downtown? More businesses? More events? Better Design? More foot traffic? Let us know!


